### **APPLICATION INSTRUCTIONS**

Final Filing Date: Continuous

Applications are accepted on a continuous basis. The cut-off-dates are the first and third Friday of each month. All completed applications and Training and Experience examinations submitted by each cut-off-date will be processed for that administration.

Note: Applications and examinations may be processed on a flow basis prior to the cutoff-date to meet the hiring needs of the department.

Dates printed on envelopes by mobile barcodes or equivalent mobile print technology are not acceptable proof of the date the application and any other required documents or materials were filed.

# Who Should Apply:

Applicants who meet the minimum qualifications as stated on this bulletin may apply for and take this examination.

Once you have taken this examination, you may not retake it for **six (6)** months.

Unless otherwise stated on this bulletin, you must meet the Minimum Qualifications by the Final Filing Date or cut-off-date stated above.

# **How To Apply:**

- **Step 1.** Applicants are required to submit an <u>Examination Application (STD 678)</u>, found at <u>www.calcareers.ca.gov</u>, either by mail, in person, or via email to the address listed below.
- Step 2. Once your application has been submitted, you must complete the **Training and Experience (T&E)** following the instructions below under, **Taking** the Examination.

# MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

# Either I

Three years of experience in the California state service as a journeyperson in one of the skilled mechanical or construction trades.

# Or II

**Experience:** Three years of experience as a journeyperson in one of the skilled mechanical or construction trades, at least one year of which shall have been in a supervisory capacity over journeyperson crews engaged in construction, maintenance, or repair of buildings and related mechanical equipment facilities. and

**Education:** Equivalent to completion of the eighth grade (additional qualifying experience may be substituted for the required education on a year-for-year basis).

# POSITION DESCRIPTION

### **UTILITY SHOPS SUPERVISOR**

Under direction, to supervise and work with a small crew of journeypersons and helpers of mixed mechanical and building trades engaged in repair, maintenance, or minor construction support activities; may instruct, lead, or supervise inmates, wards, or resident workers; and do related work.

### **EXAMINATION SCOPE**

This examination consists of the following components:

**Training and Experience Evaluation –** Weighted 100% of the final score.

The examination will consists solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

# Knowledge of:

- Methods, materials, tools and equipment used in the construction, maintenance, and repair of buildings, building equipment and mechanical equipment installations.
- 2. Codes, rules, regulation, and Safety Orders applicable to the various building and mechanical trades.
- 3. Principles of effective supervision.

- 4. Methods used in requisitioning, receiving, storing and using tools, materials, and supplies.
- 5. Department's Equal Employment Opportunity (EEO) program objectives.
- 6. A manager's role in the Equal Employment Opportunity (EEO) program and the processes available to meet affirmative action objectives.

# Ability to:

- 1. Assign, supervise, and inspect the work of building and mechanical trades journeypersons.
- 2. Read and interpret blueprints and work from plans and specifications.
- 3. Operate standard power tools and machines used in mechanical and construction trades work.
- 4. Estimate labor and material requirements.
- 5. Keep records and prepare reports.
- 6. Analyze situations accurately and take effective action.
- 7. Effectively contribute to the department's Equal Employment Opportunity (EEO) objectives.

### **ELIGIBLE LIST INFORMATION**

A servicewide, open eligible list for the Utility Shops Supervisor classification will be established for the State of California (all State of California departments, statewide).

The names of successful competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veterans status is verified by the California Department of Human Resources (CalHR). Information on this program and <a href="telepartment-of-veterans">the Veterans</a>' <a href="Perference Application">Preference Application</a> (Std. form 1093) is available online. Additional information on veteran benefits is available at the Department of Veterans Affairs.

### PREPARING FOR THE EXAMINATION

**Training:** Class titles, certifications received, names of persons who can verify your training, and phone numbers of persons listed above.

### **GENERAL INFORMATION**

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources, local offices of the Employment Development Department, and through your <u>CalCareer Account</u>.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Department of Human Resources (CalHR) reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12<sup>th</sup> grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high

school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
