Position Description

Under the direction of the District's Senior Environmental Scientist, this position coordinates the development and implementation of the Parks Online Resources for Teachers and Students (PORTS) and is responsible for developing and presenting high-quality, thematic interpretive presentations aligned with Common Core State Standards (CCSS) and the Next Generation Science Standard (NGSS) using innovative distance learning technology and providing a field science program partnership with the Orange County Department of Education.

The reporting location will be Crystal Cove State Park. The State Park Interpreter I will perform duties in direct service to the public.

Capture/obtain and prepare digital resources for use in presentations and lessons. Deliver presentations using innovative distance learning technology. Assist in planning, developing, and researching interpretive projects and developing material for interpretive exhibits. Assist in the development and publishing of social media posts in collaboration with the district's social media team.
