Briefly (1 or 2 sentences) describe the position's organization setting and major functions: Under the supervision of the Custodian Supervisor I and direction of a Custodian Lead, the incumbent performs the required janitorial services in keeping an assigned office, building, or area clean and orderly; to maintain order and supervise the conduct of Incarcerated workers, to protect and maintain the safety of persons and property, may instruct, lead, or supervise Incarcerated workers and other related work. This position may receive direction and/or assignments from the Custodian Supervisor II. Employees having regular, direct responsibility for work supervision, on-the-job training, and work performance evaluation of at least two Incarcerated workers who substantially replace civil service employees for a total of at least 120 hours per pay period may be eligible for Pay Differential 67. This pay differential may also apply to employees having direct supervisory responsibility over incumbents who meet the conditions stated above. Employees must have valid, approved medical clearance.

40%	<p align="center">ESSENTIAL FUNCTIONS</p> <p>Sweep, mop, scrub, spotting and waxing floors, vacuum rugs and carpets, operation scrubbers, buffers and other janitorial equipment and machinery: empty and clean waste receptacles, spotting walls, cleaning floors, cells stairways, hallways, restrooms and offices, clean and polish cabinets, furniture and woodwork, clean all clinic areas. Clean stairways, hallways, restroom, offices partitions, lobbies, gymnasium, medical clinics: clean ceilings, walls interior and exterior of windows, windows screens, mini blinds, upholstery cleaning, vents and grills, light fixtures, glass partitions, vents, shampoo carpets. Polish metal work: turn out lights and lock doors and windows: restock all restroom supplies replenish janitorial supplies: attends training and meetings as required. Provides instruction and on the job training for incarcerated individuals engaged in janitorial service.</p>
25%	<p>Trains in the performance of Janitorial Services Program. Responsible for assisting with daily operations, preparing list of materials/supplies to order and train incarcerated individuals. Provides training for custodial work, technical training, hands on training, assists with preparation of class instruction, and document progress.</p>
20%	<p>Maintains accurate Incarcerated individuals Work Incentive and time-keeping records. Reviews and documents work performance.</p>
10%	<p>Assist in Health and Safety Program. Ensures the Injury Illness Prevention Program complies with all CAL-OSHA requirements. This would include State Health Department in Title 22, 15, and 8. Biohazard, hazardous waste, and toxic materials control program. Ensure safety precautions to help maintain a safe work environment. Review safety inventory stock, issues as needed, and personal protective gear. Attends safety meetings, enforces safety rules as they apply to staff and incarcerated individual workers, ensures compliance with safe work practices and work conditions. Ensures the safety and security to enterprises and personnel.</p>
5%	<p align="center">MARGINAL FUNCTIONS</p> <p>Assist in moving and arranging furniture and equipment, attends special events, and helps with meeting set-up, and ensures that all areas of responsibility meet acceptable standards. Performs other duties as assigned per classification such as special projects or safety-related reports. Attends mandatory or job-related trainings and works cooperatively with the host institution staff. Group related tasks under the same percentage (%) with the highest percentage (%) first.</p> <p>(Continued from Page One)</p> <p style="text-align: center;">ADDITIONAL EXPECTATIONS</p> <p>Additionally, persons appointed to this position must be reasonably able to maintain sufficient strength, agility, and endurance to perform during stressful (physical, mental, and emotional) situations encountered on the job without compromising their health and well-being or that of their fellow employees or that of incarcerated individuals. Assignments during tour of duty may include sole responsibility for the supervision of incarcerated individuals and/or the protection of personal and real property. Persons appointed to positions in this class are required to wear a personal alarm and must carry a whistle always while on the worksite.</p> <p>Safely use and care for equipment and supplies; safely use manual and/or electric cleaning equipment; keep accurate inventories; follow directions; learn and perform routine custodial tasks; work courteously and cooperatively with others; safely lift and carry objects weighing up to 50 pounds; identify and resolve complex issues as it relates to custodial functions; utilize acceptable work habits and meet established standards; and communicate effectively.</p> <p>Ability to work in departments with incarcerated individuals or mental health patients: All of the above and maintain order and supervise incarcerated individuals; prevent escapes and injury of these persons, to themselves, to others, and to property; maintain security of work areas and work materials.</p>
