MISSION OF SECTION: Reporting to one of MSCD's Assistant Division Chiefs, the Zero Emission Infrastructure Team ensures actions are taken within and external to CARB that result in sufficient zero emission infrastructure to fuel the rapidly growing market of zero emission light-, medium-, heavy-duty and off-road vehicles and equipment.

CONCEPT OF POSITION: Under the general direction of the Assistant Division Chief, the Vehicle Program Specialist serves as the California Air Resources Board (CARB) Zero Emissions Infrastructure Specialist. The VPS is responsible for ensuring CARB and its sister agencies successfully support the Governor's Executive Order N-79-20 in the creation and implementation of Zero Emissions (ZE) Infrastructure for the State of California. Responsible for coordinating activities related to zero-emission vehicles and equipment fueling infrastructure in order to reduce emissions from the transportation and freight sectors across CARB and with State agencies and industry leaders. The VPS is also responsible for formulating zero-emission infrastructure strategies to support the State's regulatory and incentive programs which must be presented and approved by the Board.
