MISSION OF SECTION: The Equitable Mobility Incentives Branch (EMIB), develops and implements incentive projects that equitably transform the light-duty, passenger transportation sector – providing vehicle purchase options and supporting community-based mobility options – to improve the well-being and quality of life for all Californians. EMIB is responsible for overseeing the Clean Vehicle Rebate Program, financing assistance for low-income consumers' vehicle purchases, Clean Cars 4 All, California E-Bike Incentive Project, and Sustainable Community-Based Transportation Equity Mobility Projects. The Advanced Transportation Incentive Strategies Section centers equity in the evolution of clean mobility in California. The section works to mitigate and build resilience to climate change by creating or providing access to creative clean transportation options, especially in our most burdened communities. With our partners, we implement incentive projects that improve the well-being and quality of life of the communities we serve.

CONCEPT OF POSITION: Under the direction of the Air Resources Supervisor I, the Air Pollution Specialist applies scientific methods and principles in the identification, study, and solution of air pollution problems. The primary responsibilities of this position are to identify, assess, and critically analyze data and information to help prioritize innovative mobile source control strategies that reduce criteria and toxic air pollutants, as well as greenhouse gases, and to provide incentives for approaches that achieve the goals of AQIP and low carbon transportation GGRF investments. This position will also be responsible for the implementation of incentive programs and effective communication with stakeholders. The position may coordinate with local air districts, State agencies, industry stakeholders, community representatives, and others to ensure that the incentive programs are developed and implemented with public input considering the policies and regulations set by ARB. This position is responsible for carrying out the duties and responsibilities outlined below. Some travel may be required.
