

Percentage of Time Required	Effective on the date indicated, the employee assigned to the position identified above performs the following duties and responsibilities.
10%	* Conducts outreach and inspection of field sites relative to reforestation projects. *Assists in monitoring reforestation activities, including coordinating with RPFs, landowners, and land managers and implementing monitoring protocols *Assists with field work related to the establishment of Seed Production Areas *Works with staff from the California Forest Improvement Program, American Forests, California Resource Conservation Districts, and others to solicit interest in program services. *Assists entities with planting, site preparation, and monitoring activities relative to financed projects. * Assists with public education endeavors relative to program opportunities.
10%	*Assists with cone collection. *Conducts seasonal cone surveying, sampling, and collection coordination, which may involve working in a physically demanding environment, in rough/uneven terrain, or in inclement weather. *Assists contractors or other partners in field work relative to the above. *Transports cones from field location to the Center. *Stores and turns bushels on racks to keep ventilated.
5%	Other job-related duties as required. These may include emergency-related assignments. *These are the essential functions for this position. Essential functions are those functions that the individual who holds the position must be able to perform unaided or with the assistance of a reasonable accommodation.

- Job qualifications and/or conditions of employment:**
- The incumbent can be required to perform psychologically stressful and/or physically demanding duties consistent with firefighting, disaster response, and emergency medical response dependent on training and situational need.
 - May be required to wear respiratory protection equipment, including Self-Contained Breathing Apparatus – (SCBA). The use of such equipment may place a physiological burden on the incumbent that varies with the type of equipment used, the job and workplace conditions in which the equipment is used, and the medical condition of the incumbent. As such, Cal OSHA requires that the incumbent be annually medically cleared to be fit-tested for respiratory protection equipment. This clearance process consists of a comprehensive medical evaluation including a review of the incumbent’s medical history, a complete physical examination, and vision, hearing, spirometry, and exercise treadmill tests.
 - Duties involve field work requiring physical performance calling for above-average ability, endurance, and superior condition, including occasional demand for extraordinarily strenuous activities in emergencies, under adverse environmental conditions, and over extended periods of time; requires running, walking difficult climbing, jumping, twisting, bending, and lifting over 25 pounds; and the pace of work is typically set by the emergency situation.
 - Obtains training and maintains qualifications and certificates to operate all nursery equipment required, which includes receiving trainings from the Department in accordance with CalOSHA policies and procedures on how to safely operate a forklift
 - May be subject to working nights, weekends, or holidays in support of emergency incidents or program operational needs. Extended travel away from assigned headquarters, to include periodic overnight lodging, is required and will be approximately 15% of time.
 - Possession of a Class C Driver’s License.
