### Job Summary

This Syndromic Surveillance Data Analyst position within the Center for Infectious Diseases (CID), Office of Infectious Disease Preparedness and Response (OIDPR), supports the California Department of Public Health's (CDPH) mission and strategic plan by supporting the implementation, utilization, maintenance, and operation of the California statewide syndromic surveillance program (CalSyS). This program facilitates timely and broad monitoring of population health, ultimately leading to more rapid and targeted disease/injury control and prevention strategies as well as increased situational awareness for public health response.

The incumbent works under the direct supervision of the Research Data Supervisor I of the Data Quality & Integration (DQI) Unit within the Syndromic Surveillance (SyS) Section. The Research Data Analyst I (RDA I) reviews and works with data sources, information, materials, and other required resources to complete projects; collects and prepares data primarily from structured sources, and conducts basic analyses using querying, data mining, analytic and data manipulation techniques; creates fully prepared and cleansed data sets for basic analytics, spreadsheet summaries, reports, charts, and tables utilizing various software applications (BioSense/ESSENCE, SAS, R, MS Excel, SQL) while applying appropriate California Department of Public Health data privacy and security policies. Communicates both orally and in writing to individuals and groups gathering specifications and requirements related to the area of analytics service requested. The incumbent participates in data standards and quality activities and supports the syndromic surveillance inbox/helpdesk.

In the case of a public health emergency, this position may be asked to redirect to serve rotations in emergency staffing roles aligned with their classification level.

### Essential Functions (including percentage of time)

- 35% Supports CDPH programs that use syndromic surveillance, facilities, and local health jurisdictions (LHJs) on data related issues, such as queries and data feed maintenance by supporting the technical assistance inbox. Monitors and reviews data quality dashboards and reports to measure compliance, adherence, validity, timeliness, and completeness standards. Performs basic data quality and analytics with a focus on health equity, emergency response, disease/injury prevention, and other emerging Departmental goals as needed. Creates data extracts and reports using appropriate statistical methodologies utilizing computer programs and software (e.g., SQL, SAS, R, BioSense/ESSENCE). Applies CDPH standards such as small cell suppression policy and the California Health and Human Services De-identification Guidelines. Reviews and validates data products to ensure accuracy. Exchanges information and shares data products securely to CDPH programs, stakeholders, and stakeholder groups.
- 30% Supports documentation of policies, procedures, and best practices on data queries, quality control, quality assurance, and data interoperability and integration strategies. Assists in developing guidance documents for CDPH program staff relating to the use of analytics software, services, and capabilities. Reviews facility and LHJ data and identifies data quality issues. Conducts user acceptance testing and user experience testing as needed. Work with scientific staff to manage and evaluate data compliance. Supports consultation with CDPH programs and Centers for Disease Control and Prevention (CDC) to address programmatic needs with respect to interoperability, virtualization technology, health information standards (e.g., HL7), geospatial data standards and methodologies, and the CDPH implementation process supporting syndromic surveillance systems. Validates file format and naming

conventions, and ensures that minimum requirements for Office of National Coordinator for Health Information Technology (e.g., standards for interoperability, security, and accuracy), onboarding, data elements and additional criteria are met. Facilitates testing environments as needed.

- 15% Supports preparation of educational documents and development/facilitation of training presentations on topics such as the data quality metrics, and visualization of data to be disseminated to the end users. Works with team to develop an onboarding packet to include training and onboarding materials, templates, check lists, and job aids, as well as other end-user resources, as needed.
- 10% Attends regularly scheduled meetings and trainings with the CDC National Syndromic Surveillance Program (NSSP) and CDPH SyS teams. Answers correspondence, emails, phone calls, etc. Participates in data workgroup activities to solve basic data quality issues and contributes to procedural changes when appropriate.
- 5% Participates in infectious disease emergency preparedness and response activities. Completes trainings in emergency preparedness and the incident command system (ICS). During an infectious disease emergency activation, may activate to emergency response roles applicable to the position's classification level and skill set.
