Oversees academic curricula in accordance with accreditation standards; manages contracts relating to necessary clinical and academic opportunities. Performs other forensic psychiatry duties as directed by the Medical Director. Indicate the duties and responsibilities assigned to the position and the % of time percentage of time spent on each. Administers and maintains the Staff Psychiatrists (Safety) participating in the Forensic Psychiatry Fellowship Program, conducive to educating the fellows in each of the Accreditation Council for Graduate Medical Education (ACGME) competency areas. Oversees and ensures the quality of didactic, forensic, and clinical education in 45% the program; approves the selection of program faculty as appropriate; evaluates program faculty; approves the continued participation of program faculty based on evaluation; monitors fellow supervision within the program; monitors the need for and ensures the provision of backup support systems when patient care responsibilities are unusually difficult or prolonged.
