## **Job Summary**

This position supports the California Department of Public Health's mission and strategic plan by partnering with education and health organizations at the state and local level to support the health, safety, and well-being of California's 7.5 million students, staff, and their communities in the state's 10,000 TK-12 schools. The Office of School Health (OSH) develops and disseminates scientific guidance and policies; supports school-based health centers; and facilitates collaboration between state and local education and health officials.

The Health Program Specialist II (HPS II), serves as the Community and Youth Engagement Specialist and works closely with TK-12<sup>th</sup> grade schools, education partners, vendors, and program specialists within OSH in student behavioral health and related programs. Facilitates behavioral health planning

activities, outreach, and engagement to plan for school-based prevention support and strategies identified in State Bill (SB) 326. Builds relationships specific to behavioral health between the OSH, vendors working in youth engagement, and education partners. Responsible for coordinating and collaborating with those planning state-wide behavioral health prevention efforts.

The HPS II works under the direction of the Health Program Manager II (HPM II), Chief of the OSH.

- Leads community and youth engagement activities on behavioral health issues involving TK12<sup>th</sup> grade students and their families, also focusing on culturally responsive behavioral health
  promotion, risk reduction, and recovery. Leads an interdisciplinary team of program specialists,
  external partners, and consultants to conduct youth engagement activities including focus
  groups, listening sessions, surveys, key informant interviews, and other activities to support
  population-based behavioral health prevention activities and programs. Aligns program and
  funding proposals with public health best practices, leads strategic planning, communications,
  and implements the integration of behavioral health practices through community engagement,
  training, and technical assistance. Supports behavioral health programs by implementing
  prevention strategies tailored to diverse populations and manages program deliverables and
  quality improvement initiatives.
- 30% Initiates and maintains outreach to support capacity building for TK-12<sup>th</sup> grade educators and program staff by coordinating webinars, trainings, speaker engagements, and facilitates resource groups to integrate best practices in youth engagement activities that promote diversity, equity, inclusion, and belonging in youth behavioral health programs and activities. Builds expertise in evidence-based strategies for supporting youth behavioral health, leads special projects to advance population-based behavioral health initiatives, and utilizes data to monitor program success. Fosters collaboration with other programs and state agencies, representing the department in school health discussions and engaging with external advocacy organizations to promote school-based health initiatives.
- 15% Fosters inclusive relationships with internal and external partners, staying updated on behavioral health research, policy, and legislative changes to ensure effective development and

implementation of new policies, programs, and initiatives. Tracks initiatives from inception to execution, providing status updates and recommendations to leadership on any challenges encountered. Oversees workgroups, collaborates on program development, provides technical assistance, updates policies and procedures, and conducts research to support OSH priorities, producing documentation for various audiences and ensures all materials are accurate and accessible.

10% Provides ad-hoc consultation to OSH, local health jurisdictions, universities, and behavioral health departments, assisting them and their community partners in planning public health strategies and school-based prevention supports that promote behavioral health and align with State Bill (SB) 326. Facilitates communication with local agencies and universities, conducting policy and programmatic analyses, and managing Requests for Proposals (RFPs) and Requests for Applications (RFAs) while overseeing fiscal and contract management. Prepares reports and scientific papers, engages in technical writing for legislative analyses and internal policies, and contributes to various documentation efforts to support the program's objectives.
