<u>MISSION OF SECTION</u>: The mission of the Climate Investments Branch (CIB) is to advance State policies and investments that address climate change and advance equity with a primary focus on implementing California Climate Investments and developing tools, resources, and strategic partnerships.

CONCEPT OF POSITION: The Staff Air Pollution Specialist (SAPS) will work closely with the Branch Chief, the Division Office, and other managers within the CIB and STCD to meet the goals of CIB and STCD through collaborative leadership, expertise, and initiative. This SAPS is responsible for the organization of joint public meetings with the California Transportation Commission (CTC) and the Department of Housing and Community Development (HCD) to develop integrated policies that address transportation, housing, climate and air quality challenges. This position leads efforts to align transportation investments with statewide climate and equity objectives to reduce emissions and vehicle miles traveled while delivering environmental, social, and economic cobenefits, particularly in disadvantaged and low-income communities. This SAPS will also support the continuous improvement of California Climate Investments and contributes to CIB's efforts to promote the program as a model for national and international replication, helping to scale the impact of the state's climate leadership. Travel within California will be required.
