## Job Summary

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by monitoring public health hazards and providing emergency response communication in support of the health and wellbeing of California's diverse people and communities.

The incumbent works under the direction of the Program Manager II of the 24/7 Intelligence Section, Program and Response Branch, Center for Preparedness and Response. The Emergency Services Coordinator, Office of Emergency Services (ESC) will work within the 24/7 Intelligence Section, which operates in 8-hour shifts, 24 hours a day, seven days a week watching over California to identify

potential and emerging public health threats, provide alert notification to all levels of government as well as critical situational awareness during an emergency or disaster. The incumbent is expected to rotate through various work schedules including day, swing, and night shifts.

- Produces threat and disaster-related work products in support of the CPR including daily public health intelligence reports, advanced planning documentation such as a 7-day public health threat outlooks, and other reports relating to chemical, biological, radiological and nuclear threats for situational awareness of active and potential public health and medical incidents. Sources intelligence information from various monitoring systems, platforms, organizations, and opensource media to effectively collect, deconflict, produce, and disseminate critical intelligence products. Disseminates intelligence reports to both internal and external stakeholders to ensure real-time situational awareness on emerging public health threats, emergencies, and trends.
- Serves as a technical and programmatic subject matter expert (SME) for public health coordination within the CPR. Works as part of a team responsible for maintaining 24/7 situational awareness for all public health and medical inquiries and intelligence-gathered. Provides review, support, and communication for complex CDPH Duty Officer inbox requests and responses. Works with appropriate Public Health and Medical SMEs to gather intelligence which evaluates and vets all incoming intelligence sources to inform the CPR management and personnel of potential public health threats. Identifies needs and emergency management systems deficits and develops recommendations for improvement. Works with section Research Data Analysts to analyze incoming data sources, review and synthesize surveillance, and monitor data to inform response operations and communication priorities. Maintains a working knowledge of the Standardized Emergency Management System (SEMS), the National Incident Management System (NIMS), the CDPH Emergency Operations Response Plan (EORP) and the California Public Health and Medical Emergency Operations Manual (EOM).
- 20% Maintains a working knowledge of Incident Command Systems (ICS) and the Medical and Health Coordination Center (MHCC) principles and structure, including all sections within the MHCC. Maintains awareness of priorities and functions to ensure continuity of operations within the MHCC organizational structure during activations. Works with CDPH Centers, Programs, and the CPR executive management team in support of identifying emerging public health threats and emergency response and recovery operations. SME for alert notifications for all levels of

government and provides critical situational awareness during an emergency or disaster. Utilizes and trains others on the California Health Alert Network (CAHAN) platform to effectively disseminate critical health information and guidance when necessary. Trains staff in principles and methods of risk assessment and communication.

Participates in workshops, drills, and training exercises on public health emergency awareness and response (e.g., SEMS/NIMS, Disaster Service Worker, MHCC, Strategic National Stockpile, etc.). Travel is required to attend meetings, participate in workgroups, exercises, and trainings.

## Marginal Functions (including percentage of time)

Performs other job-related duties as required. In the event of an emergency activation, the incumbent may be required, on short notice, to work irregular and overtime hours during disaster operations.
