## Job Summary

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by monitoring clinical laboratory licensure and inspection.

The Examiner III is responsible for overseeing timely in-state and out-of-state clinical laboratory inspections, investigating facility and personnel complaints, and coordinating enforcement actions, including license revocations and civil penalties. The role manages accrediting organization (AO) approvals, monitors AO performance, and oversees validation surveys.

The Examiner III collaborates with the Office of the Attorney General and CDPH's Office of Legal

Services (OLS) on legal actions and ensures compliance with federal and state regulations. As a Subject Matter Expert, the Examiner III provides expert guidance, participates in hearings, offers legislative testimony, and addresses complex licensing inquiries.

The incumbent works under the general direction of the Branch Chief of Laboratory Field Services.

35% The Examiner III ensures timely completion of in-state and out-of-state (OOS) clinical laboratory licensure inspections, completing facility and onsite personnel complaint investigations, and overseeing and coordinating enforcement up to and including license revocation and/or civil money penalties. Collaborates with the Office of the Attorney General and CDPH's Office of Legal Services (OLS) in the preparation, presentation and defense of legal actions. Responsible for ensuring the Section's compliance with federal and state laws and regulations. Serves as a Subject Matter Expert (SME) in facility licensing, participates in hearings as needed, provides legislative testimony, and responds to complex technical inquiries.

Provides supervision and direction to Examiner II and I staff who are responsible for in-state and out-of-state clinical laboratory licensing and inspections, Clinical Laboratory Improvement Amendments (CLIA) federal certification, proficiency testing, enforcement, and oversight of public health laboratories and biologic laboratories. Ensures clinical laboratories and related medical facilities compliance with state and federal requirements. Reviews site survey reports and corrective action plans for accuracy, appropriateness and clarity. Oversees the development and maintenance of annual and monthly survey planning. Monitors and tracks assigned surveys to meet required deadlines.

35% Directly supervises staff, including hiring, training, performance evaluations, counseling, and corrective actions through counseling memos and adverse actions, in coordination with the LFS Assistant Branch Chief. Maintains and prepares duty statements, probation reports and individual development plans. Prepares worker's compensation claims, injury and accident forms, and responds appropriately to employee complaints as necessary. Approves leave requests, CalATER reimbursements, and training requests in a timely manner. Ensures high-quality work output and compliance with federal and state laws and regulations, and departmental mandates through quality assurance activities and

performance management. Conducts regular staff meetings and monitors workload distribution. Supports CDPH's Affirmative Action, Civil Rights, and Equal Employment Opportunity policies.

25% Prepares budgets, bill analyses, policy reports, and correspondence. Develops legislative concepts, proposals and regulations related to facility licensing. Coordinates with the Assistant Branch Chief on budgeting for travel, supplies, and services. Oversees accrediting organization (AO) approvals, serves as the lead liaison, and monitors AO performance.

Initiates and prepares disciplinary actions for licensee in coordination with the Office of the Attorney General and OLS for facility license suspensions or revocations. Serves as a SME in hearings and provide legislative testimony. Supports development and maintenance of the electronic licensing system in collaboration with IT and Program Support. Represents the Section in stakeholder meetings and interdepartmental committees, and prepares reports and presentations for internal and external audiences.
