### **General Description**

Under direction, incumbents perform a wide variety of complex tasks requiring innovative problem solving within broadly stated and non-specific guidelines. The scope typically spans multiple program areas and includes planning, developing, and implementing technological solutions that are essential to the organization's mission or that impact large numbers of stakeholders on a long-term and continuous basis. Work is performed in the domains of Software Engineering and Systems Engineering.

Typical tasks performed within each domain may include:

#### **Software Engineering**

- Define, design, and architect software solutions using industry standards, modern frameworks, and established methodologies.
- Develop and maintain software documentation throughout all phases of the system development life cycle (SDLC) to ensure maintainability and future enhancements.
- Perform software deployment, release management, and configuration management activities.
- Develop plans and execute tasks related to system design, coding, testing, defect management, integration, implementation, and documentation of software components.
- Develop, update, and implement coding standards, development procedures, automation strategies, and controls to ensure proper installation, configuration, security, reliability, and availability of applications and related databases.

#### **System Engineering**

- Advice, design, and participate in the development of system architecture, patterns, standards, and methods to support organizational needs.
- Conduct research and perform analysis to recommend system upgrades, cost-effective solutions, cloud services, and process improvements for current and future requirements.
- Consult with business and technical stakeholders to identify infrastructure and system requirements; recommend appropriate technologies, configurations, and implementation plans.
- Coordinate and support system installation, cloud deployments, operations, maintenance, repairs, and upgrades.
- Execute and validate test plans for system releases, upgrades, and cloud transitions.
- Install, configure, administer, test, and maintain systems, services, and communication components in cloud and hybrid environments.
- Troubleshoot, track, and conduct root cause analysis of system, application, or database issues using established processes, escalating issues when necessary.

The incumbent serves as a technical expert and business analyst within the Development Services Group (DSG), Digital Services Branch (DSB). They are part of a highly skilled team responsible for supporting and enhancing HCAI's core services by delivering enterprise IT solutions.

The incumbent is expected to operate effectively in a dynamic and fast-paced environment, quickly learn new technologies, adapt to changing priorities, communicate clearly with technical and non-technical staff, and provide excellent customer service.

The incumbent independently performs complex programming, system integration, and analysis tasks; serves as a subject matter expert; and collaborates with other technical staff on large-scale, multi-tier, cloud-based enterprise applications.
