<b>ESSENTIAL FUNCTIONS</b>						
<b>25%</b>	Supervise the development, implementation and coordination of clinical activities and standards for effective and efficient delivery of mental health services in a MHCB.					
<b>20%</b>	Supervise the selection, hiring and performance of staff level Psychiatrists, Psychologists, and assist in the coordination of their activities with those of other professional and supportive staff in the Service Area.					
<b>20%</b>	For a MHCB having less than six beds, the Senior Psychiatrist (Supervisor) shall provide direct clinical services to incarcerated individuals, including pre-admission screening of referred incarcerated individuals, admission and discharge, evaluation and crisis intervention treatment and medication prescription for MHCB incarcerated individuals. (If this duty requires more than 20% of the Senior Psychiatrist's time, other duties will decrease proportionally.)					
<b>10%</b>	Supervise studies and audits of mental health services to identify deficiencies and recommend corrective actions to provide effective and efficient delivery of mental health care; supervise the development, implementation and management of corrective action plans to correct program deficiencies.

	<p><b>KNOWLEDGE AND ABILITIES</b></p> <p><i>Knowledge of:</i> Principles and methods of psychiatry, and skill in their application; current developments in the field of psychiatry; mental health care organization and procedures; principles and application of psychiatric social work, clinical psychology, physical therapy, various rehabilitation therapies, and other ancillary medical services; principles and techniques of psychiatric research; and principles and practices of effective supervision and directing health care providers.</p> <p><i>Ability to:</i> Direct the work of others; instruct in the principles and practices of psychiatry; interpret laboratory analyses; prepare and supervise the preparation of case histories and the keeping of health care records; analyze situations accurately and take effective action; maintain effective working relationships with health care professionals and others; and communicate effectively.</p> <p><b>SPECIAL REQUIREMENTS OR CONTINUING EDUCATION REQUIREMENT</b></p> <ul style="list-style-type: none"> <li>• CCHCS does not recognize hostages for bargaining purposes.
