Schedules repairs or service with commercial vendors when deemed necessary and approved by the FEM I. \*Inspects and keeps appropriate documentation for all outside work performed on equipment. 10% \*Completes safety inspections on all vehicles arriving for annual maintenance in compliance with CAL FIRE/SCFD standards. Implements a comprehensive annual maintenance program for all apparatus and support equipment with the guidance and direction of the FEM I. 5% Other duties as required.
