**1. MAJOR TASKS, DUTIES, AND RESPONSIBILITIES**

Under general direction, to perform a variety of skilled work in the operation, maintenance, and repair of boiler, heating, air conditioning, ventilating, lighting, power, water, water treatment, and other mechanical systems normally found in a State hospital, institution, large office building or complex of buildings; may instruct or lead other engineers; may instruct or lead resident workers; and, do other related work.

30% Operates and repairs building equipment and facility utilities such as boilers and auxiliary boiler room equipment, heating, lighting, ventilating, air conditioning, power, refrigeration, building electric and pneumatic controls, water treatment and other mechanical or electrical equipment, as generated by work orders and as assigned by the Chief Engineer I.

30% Performs preventive maintenance tasks on building equipment and facility utilities outlined above, utilizing appropriate methods, tools, and materials, as assigned by the Chief Engineer I.

10% Plans layouts and calculates systems requirements to provide estimates for modification or replacement of systems, at the direction of the Chief Engineer I. Prepares Service Orders and Intra-Office Requisitions for parts, supplies, and equipment.

10% Performs inspections and troubleshoots electrical and mechanical systems and equipment to identify repairs needed. Prepares and keeps accurate records and reports, such as meter readings, fuel usage, steam output and peak steam load, as directed by the Chief Engineer I.

5% Other related duties as required.

15% **SITE SPECIFIC DUTIES**  
Operates and maintains the co-generation plant and auxiliary equipment, as needed.

Follow oral and written directions; demonstrate mechanical ability; keep accurate records; install, operate and make repairs to the various types of equipment listed above in the knowledge requirements; make written reports, read, interpret, and work from plans, drawings and specifications; lay out work for others and direct them in this work; and, analyze situations accurately and take effective action.
