POSITION DESCRIPTION		
Under the supervision of the Public Safety Superintendent II and State Park Peace Officer Supervisor (Ranger), the incumbent is responsible for the handling and training of a patrol dog and visitor services duties at Hearst San Simeon State Historical Monument (HSSSHM) and Visitor Center, including leading lower-level seasonal employees to perform routine public contact, public assistance, all associated canine handler duties, training and responsibilities, and general security in a State Park facility. Responsible for performing law enforcement duties, responsible public contact work and provide visitor services, and complete other related work. Walk the grounds of HSSSHM on a regular basis and respond to public safety incidents. Reporting location is HSSSHM/Hilltop. State housing may be required for this position.

%	TASK/DUTIES	
35%	Public Safety and Law Enforcement With canine: Enforce all applicable laws, rules, and regulations. Patrol primarily by vehicle and foot patrol to identify and prevent illegal activities; issue citations; make physical arrests; transports prisoners to jail as needed to complete enforcement actions: perform search and rescue activities and take command in emergencies. Secure monument buildings and roadway gates as needed, respond to alarms, and security detection systems. Operate dispatch; conduct traffic control (i.e., pedestrian, vehicle, vessel, bicycle); render first aid; assist other agencies in emergency or medical incidents, and conduct searches for lost persons. Prepare and complete all required reports (crime, canine use, use of force, accident, park damage, citations, warnings); conduct criminal and administrative investigations, maintain chain of evidence on all physical evidence taken and held; maintain relations with other law enforcement agencies, and attend court as required. Assist visitors in distress (medical aids, assisting with disabled vehicles, camper problems); maintain awareness of situations hazardous to employees and/or visitors, and assist in the development of crime prevention programs. Cooperates with other agencies by attending law enforcement meetings; and has informal communications with other agencies to gain knowledge of law enforcement related matters. Assist coastal ranger staff with law enforcement and rescue operations.	
25%	Patrol K-9 and Explosives Detection Training	

	Participates in Patrol K-9 and Explosives Detection Training at HSSSHM and Department-wide. Maintain the standards set in the Department's K-9 Handbook. The K9 Handler shall maintain canine team skills with weekly proficiency training to include physical fitness, grooming, kennel maintenance, obedience, protection, searching, tracking, and detection. Minimum Patrol K9 training hours = 16 hours and Minimum Detection K9 training hours = 8.
20%	Resource Management and Maintenance Monitor and report adverse visitor impact on natural and cultural resources within assigned area(s), and assist in impact abatement and erosion control activities. Assist in wild land and structural fire suppression. Assist in the planning, development and implementation of various resource management projects. Operate, inspect, and perform maintenance on emergency rescue equipment and vehicles. Remediate and/or report environmental hazards to ensure public and employee safety. Conduct daily maintenance and equipment checks and monthly inspections of the K-9 Team patrol vehicle. Maintain up-to-date maintenance records on patrol vehicle and submit repair requests when needed. Maintain cleanliness of barracks and shared space sleeping quarters, restrooms, kitchens, and offices.
15%	Administration and Interpretation Maintain and review canine program documentation with supervision as required by policy and industry standards. Assist in identifying and purchasing canine equipment and supplies. Maintain required public safety and visitor services training, prepare and present seasonal employee orientation, participate and/or present in-service training at the district level for a variety of topics such as but not limited to, range, defensive tactics, interpretive techniques, visitor services, and aquatic and public safety. Plan, prepare, and present Campfire programs, Junior Ranger programs, nature walks, interpretive displays, school programs, and impromptu interpretive programs throughout the district.

5%	Performs other job-related duties as necessary for operational continuity.
TYPICAL WORKING CONDITIONS	
Work involves moderate exposure to unusual elements, such as extreme temperatures, dirt, dust, fumes, smoke, unpleasant odors, loud noises, inclement weather, in old/abandoned structures and around sewage/trash. Work environment involves some exposure to hazards or physical risks, which require following basic safety precautions. Ability to work in a variety of environments including cold, windy, wet, and muddy conditions along lakes, creek banks, wetlands, rocks, brush, etc. Ability to work in hot, dry, muggy or unpleasant conditions. Typical work activities involve frequent and prolonged periods of standing and walking, as well as prolonged periods of driving.

This position requires that the incumbent maintain the minimum training requirements as set forth in the Department K9 Manual and successfully complete the annual Department K9 Qualifications. A valid Driver's License Class "C" is required. Annual proficiency testing is required by the Department Training Program and certified by the P.O.S.T.
