### **Job Summary**

This position supports the California Department of Public Health's (CDPH) mission and strategic plan by serving a vital role as an epidemiologist within the Informatics Branch (IB) of the CDPH Center for Infectious Diseases (CID).

The Research Scientist III (RS III) supports the modernization, integration, and interpretation of critical Center-wide data streams which enable reportable infectious disease surveillance in California. In this role, the RS III collaborates with IB staff and the Center for Infectious Diseases' (CID) programs to modernize data infrastructure and improve stakeholder access to reportable infectious disease

data under the purview of CID.

The RS III develops, plans, organizes, and directs collection, extraction, analysis, interpretation and reporting of reportable infectious disease data to fulfill the Center's statutory obligations to characterize the burden of reportable infectious diseases among people of different races and ethnicities, sexual orientations, gender identities, and sexes assigned at birth, along with other key epidemiologic, clinical, and demographic disease determinants. The RS III contributes to departmental-wide strategies that promote more effective collection, storage, analysis, interpretation, and dissemination of data that promote public health activities.

The work of the RS III directly supports the mission of the Center for Infectious Diseases to protect the people of California from preventable infectious diseases and assist those living with an infectious disease in accessing timely and appropriate healthcare, medications and associated support service.

The RS III works under general direction of the Research Scientist Manager of the Informatics Branch.

### **Essential Functions (including percentage of time)**

- 25% Plans and directs the effective and accurate collection of demographic data from individuals diagnosed with infectious diseases in the state of California. Leads the development of standardized data collection forms developed by other research scientists and program staff to collect these data and directs their implementation in CID surveillance systems. Reviews and provides input on technical documentation and policy guidance from more junior research scientist, CID, U.S. Department of Health and Human Services and CDPH leadership, and community partners to ensure compliance with demographic data collection standards. Collaborates with other subject matter experts to interpret statutory guidance and coordinates with internal CDPH programs and local health departments to develop best practices for eliciting demographic data through tools such as electronic laboratory reports (ELR), electronic case reports (eCR), patient interviews, etc.
- 25% Responsible for planning organizing, and directing the synthesis, analysis, and reporting of demographic data among individuals infected with infectious diseases in California. Directs the development and implementation of standards and best practices for data extraction (from data systems), integration, and analysis. Advises and guides CDPH Program, Informatics Branch (IB), and Departmental leadership to develop, publish, and automate an annual statewide report on infectious disease trends among people with different sexual orientation, gender identities, sexes assigned at birth, races, and ethnicities. Coordinates with programs and local health departments to contextualize findings, their implications for infectious disease surveillance and

response activities, and develops tools for reporting and visualization.

- 20% Participates in national, state, and local work groups focused on policies, and guidelines for data collection, management, and dissemination best practices. Assesses and reviews content from other staff and delivers technical expertise to clearly convey best practices. Collaborates with local health departments and community partners to identify and promote effective demographic data practices. Responds to technical assistance requests and performs troubleshooting in coordination with CID, CDPH programs, and local health departments. Participates in ongoing and ad-hoc work groups, including those organized by the Council of State and Territorial Epidemiologists (CSTE) and the California Conference of Local Health Data Managers and Epidemiologists (CCLHDME). Actively participates in regular team, Branch, Division, and Center meetings, as well as strategic planning activities, training, and working groups. Represent CDPH in meetings with leadership, Local Health Departments (LHD), academic partners, and other key stakeholders. Leads and coordinates presentations for these groups with other IB and CID staff.
- 15% Contributes to data modernization efforts within CID by developing processes and participating in initiatives that allow for enhanced interoperability of disparate data sets, enhanced surveillance and response activities, reduced repetitive manual surveillance tasks undertaken by CID and LHD partners, and more efficient emergency response efforts in CID.
- 10% Performs other analysis and reporting activities of data collected pursuant to California statute at the discretion of Branch, Center, or Departmental leadership to support CID in fulfilling departmental priorities, including emergency responses to emergent infectious diseases and other outbreaks.
