Provide direction to and ensure performance accountability of MHCB psychiatric/psychological staff efforts to comply with Correctional Treatment Center licensing requirements. Supervise preparation of or actually prepare reports for the Mentally Disordered Incarcerated Person (PC 2960-2981) [except 2974] program. Participate in automated data management and other health care records systems. Attend in and out service training and perform other duties as required.
	KNOWLEDGE AND ABILITIES <i>Knowledge of:</i> Principles and methods of psychiatry, and skill in their application; current developments in the field of psychiatry; mental health care organization and procedures; principles and application of psychiatric social work, clinical psychology, physical therapy, various rehabilitation therapies, and other ancillary medical services; principles and techniques of psychiatric research; and principles and practices of effective supervision and directing health care providers. <i>Ability to:</i> Direct the work of others; instruct in the principles and practices of psychiatry; interpret laboratory analyses; prepare and supervise the preparation of case histories and the keeping of health care records; analyze situations accurately and take effective action; maintain effective working relationships with health care professionals and others; and communicate effectively.
