Job Description Summary

Under the general direction of the California High-Speed Rail Authority's (Authority) Principal Transportation Engineer (PTE), the Supervising Transportation Engineer (Third Party Unit Manager) will provide direction and oversight of the development, management, and implementation of the Third Party activities required for the High-Speed Rail program. The incumbent will ensure the Third Party policies, procedures, and approaches are implemented with the highest legal and ethical standards during the planning, development, and operation of the project. The incumbent will provide oversight and direction to assigned teams, support the delivery of projects, and may represent the office in discussions with other functional units regarding operational and administrative elements of Third Party. The incumbent will oversee the development of work standards, monitor the attainment of those standards, establish consistent work processes, and ensure the development of a customer service-oriented office.

The incumbent performs highly complex assignments and independently performs coordination activities to relocate or remove utility facilities that are either in physical conflict or in violation of the department's utility accommodation policy for projects pursuant to established policies and procedures and applicable state and federal laws and regulations.

 - Responsible for managing all utility owner relocations for the program.
 - Reviews all utility relocations for contract compliance and verifies completion of work.

- Manages the Authority's Third Party Section and ensures all necessary deadlines and expectations in responding to project partners, stakeholders, and community member inquiries related to the project elements in a timely manner.
 - Develops and implements office strategies and makes recommendations to the PTE and upper management on the Third Party Section's policies, procedures, performance, operations, and program issues.

- Serves as the point of contact between project development staff, consultants, local public agency project sponsors and utility owners throughout the planning, design, review, and approval stages of utility conflict identification and relocation plan development through construction and closeout.
 - Verifies positive location requirements for all high/low risk utility facility within the project limits.
 - Review of encroachment permits, high/low risk exceptions, design agreements, Notice to Owners, Utility Agreements, encroachment permits and Right of Way certification for proposed construction projects. Utility verification with all affected Utility Owners to include all work associated with.
 - Ensures that newly adopted policies and procedures are complied, conveyed, and instituted throughout the section.

- Develops and provides recommendations to the PTE and upper management on the formulation and administration of policies and long-term goals of the Third Party Section.
 - Provides periodic performance reports and updates on the status of various projects to the PTE and upper management.
 - Oversees and verifies property rights conveyance to Utility Owners to include recordation of deeds and verification that this recorded information has been entered on State Record maps. These property right conveyances include: Joint Use Agreements, Consent to Common Use Agreements, Director Deeds and Easements.

- Participates in the recruitment, hiring and training of the Third Party Section staff.
 - Performs contract management duties for Third Party Utility agreements by ensuring compliance with contract terms, approving invoices, resolving disputes, tracking budgets and expenditures, and overseeing timely contract closeout.
 - Supports analysis regarding resource utilization and office space needs, prepares special studies critical to the management of

- May be responsible for overseeing other Third Party Units in the absence of the PTE and as business needs arise.
