	ESSENTIAL FUNCTIONS					
40%	Directly supervises Physicians & Surgeons, Nurse Practitioners, and Physician Assistants (henceforth referred to as medical providers). Participates directly in the hiring process, and re-credentialing and privileging process for the medical providers. Ensures that hired medical providers receive initial orientation, comprehensive onboarding and ongoing training consistent with statewide standards, and that the medical providers participate in continuing education activities. Oversees the implementation of local professional practice processes and the appropriate assignment of patients to providers based upon case complexity and provider credentials. Regularly monitors, assesses, and documents the quality of clinical services provided by the medical providers based on professional standards and Department policy. Provides notification to the Chief Medical Executive of all serious clinical practice issues.					

25%	Ensures implementation of Complete Care Model and medical services consistent with community standards, legal mandates, California Correctional Health Care Services (CCHCS) and California Department of Corrections and Rehabilitation policies and procedures and organizational goals. In partnership with nursing supervisors, oversees medical clinic operations at the assigned institution and responds to health care delivery problems presented by institution staff or managers. Works collaboratively with staff in a variety of disciplines, including nursing, mental health, dental, tele-health, laboratory, imaging, pharmacy, and custody staff, to effectively coordinate patient care. Ensures safe, timely, and effective transfers of patients to or from other institutions, higher levels of care, and during reception center processing. Ensures provider documentation and responses are appropriate and timely. Ensures medical providers effectively use the Electronic Health Record System and patient registries and other care tools. Ensures medical providers participate in daily huddles and facilitates regular Population Management Working sessions and provider meetings.
20%	Serves as a member of the institution's leadership staff; participates in various quality improvement, patient safety, and peer review forums. Reviews aggregate performance, operational and clinical data including, but not limited to, the Health Care Services Dashboard, Medical Services Reports, Joint Commission, and Office of the Inspector General Inspection Reports to identify opportunities to improve patient outcomes, and the timeliness, safety, quality, and cost-effectiveness of clinical care processes and practices. Forwards data and analyses related to reportable contagious diseases to the designated CCHCS Public Health Branch staff. Assists the Department in determining health care priorities, plans, policies, programs, and identifying related resource needs. Serves as a departmental advisor on the pragmatic application of CCHCS policies and procedures in the field. Oversees a high value utilization management system to support ongoing program evaluation and improvement, including maintaining an effective system for minimizing under- or over-utilization of both on-site, and off-site specialty services including services delivered via videoconferencing; optimizes delivery of specialty services to minimize unnecessary transports outside of the institution; and implements a process to review prescribing practices in order to identify and mitigate potentially inefficient, ineffective, and harmful medications. Authorizes requests for designated specialty services. Reviews off-site hospitalizations and emergency Department encounters to identify strategies for reducing potentially avoidable and inappropriate use. Ensures that all off-site medical consultations are timely performed.
