40%	Under the direction of the South Operations Assistant Chief, the Battalion Chief performs the following: *Supervises subordinate personnel, which includes assignment of work, training, safety, scheduling, evaluations, processing of grievances, discipline and other administrative duties. *Responsible for maintaining all necessary records, inventories, maps, files, etc. to properly administer the CAL FIRE and local government programs. *See that all reports, financial and personnel documents are submitted in a timely manner. *Assures the proper operation of fire stations under their control.		
20%	*Responsible to assure all fires in their area are investigated to determine cause and origin and all fire laws violations will be evaluated and the proper enforcement action taken. *As requested, provides an ongoing prevention program for all groups, schools and clubs. *Works with local news media and supplies prevention literature to those who request it for distribution. *Supervises an inspection program, which includes the Public Resources Code and Health & Safety Code with regards to powerlines, dumps, equipment, camps and burning operations. *Annually prepares a unit district fire prevention plan and a unit district burning permit plan. *Reviews plans for subdivision, commercial developments and use permits to assure compliance with fire safety codes and ordinances.		
15%	*Responsible to take control of any fire within their area unless relieved of duty. *Responsible for the readiness and training of their subordinates in current firefighting techniques. *Maintains the county resource directory as it pertains to their area and has current knowledge of the equipment operated by the volunteer fire companies and fire districts. *Maintains working knowledge in rescue and first aid.

Percentage of Time Required Effective on the date indicated, the employee assigned to the position identified above performs the following duties and responsibilities.

- 10% Works with landowners and managers to provide a coordinated effort in implementing the CALFIRE resources program. Conducts vegetation management and range management burns. Provides information and referrals for specific resource programs.
- 10% Works with volunteer fire companies to determine equipment and training needs. Coordinates fire training for volunteer fire companies. Assists volunteer fire companies with any problems they might have and coordinates their fire suppression activities. Promotes the CALFIRE mission. Coordinates fire suppression, burning permits, administration and training with the other fire agencies in the county.
- 5% Other duties as required.

The incumbent is required to wear respiratory protection equipment (including self-contained breathing apparatus (SCBA). The use of such equipment may place a physiological burden on the incumbent that varies with the type of equipment used, the job and workplace conditions in which the equipment is used, and the medical status of the incumbent. As such, Cal/OSHA requires that the incumbent be annually medically cleared to be fit-tested for respiratory protection equipment. This clearance process consists of a comprehensive medical evaluation including a review of the incumbent's medical history, a complete physical examination, and vision, hearing, spirometry, and exercise treadmill test.

The incumbent typically is required to perform psychologically stressful and/or physically demanding duties consistent with firefighting, disaster response, and emergency medical response, including working in isolated areas, walking or running on uneven rough terrain, and remaining on duty 24 hours or longer without a break while performing these duties.
