40%	Under the general direction of the Supervisor of Building Trades within Technical Services, the Maintenance Mechanic (MM) performs miscellaneous skilled work which includes maintenance, alterations and improvements, repair of buildings, and mechanical systems. Responsibilities include but are not limited to inspecting, maintaining and repairing; plumbing, heating, water and sewer systems, electrical systems, and assisting with minor building construction. The incumbent will perform the following duties: *Completes maintenance on all assigned Southern Region and Units facilities (e.g. buildings, offices, and utilities) while ensuring the standards set forth by the Department of Forestry & Fire Protection (CAL FIRE), State Fire Marshall's Office (OSFM), Division of State Architect (DSA), and at times the California Department of Corrections and Rehabilitation (CDCR) are met. *Meets certification and proficiency requirements of the Department of Public Health to maintain public water systems. *Inspects, maintains, and repairs minor building construction and repair work on plumbing, heating/cooling, and water systems. *Completes electrical maintenance and repair work on shop equipment. *Advises supervisor of delays in projects within a timely manner.		
30%	*Assists in planning projects, setting goals, obtaining materials, and ensuring professional completion of projects. *Prepares cost estimates and requisitions for materials and supplies. *Records all purchases and project work and prepares reports as necessary. *Creates, pulls and submits project reports for Supervisors and Administration staff when asked.		
15%	*Ensures all property and tools assigned to the MM are properly maintained and in safe operating condition. *Keeps property secure from damage and theft at all times. *Maintains property records as required by CAL FIRE policy. *Reports damage and/or theft of property promptly. *These are the essential functions for this position. Essential functions are those functions that the individual who holds the position must be able to perform unaided or with the assistance of a reasonable accommodation.
