FUNCTION OF POSITION

This involves removal and installation of highly complex emergency equipment, performing mechanical and electrical repairs, and scheduling repairs with vendors, for the Fleet Operations Section's Vehicle Sales Unit.

Incumbents are required to crawl underneath a vehicle/down under the dashboard/into the trunk; lift and carry tires up to 60 pounds in weight; and work in varying, and sometimes extreme, temperatures.

| 55% | Disassemble run-out vehicle's interior and body trim to gain access to equipment; recover, process, and document any drugs, weapons, or other paraphernalia found in vehicles during disassembly process; utilize and operate power tools, hand tools, and other equipment to remove highly complex emergency equipment (i.e., Consolidated Patrol Vehicle Environment system, Mobile Video/Audio Recording Systems, Wireless Mobile Video/Audio Recording Systems, Emergency Vehicle 2020 (EV 20) Systems, K-9 Vehicle Systems, Emergency Warning Light System, wiring circuit, brackets, and prisoner restraint system); remove decals from vehicles; restore and repair original wiring circuitry; modify equipment configuration for reassignment purposes; design and fabricate metal brackets and equipment for installation into vehicles; and remove and reinstall highly complex emergency equipment from vehicles going to vendor for body repair. |
| 20% | Inspect run-out vehicles for safety-related items, necessary mechanical repairs, and body damage; perform needed minor mechanical and electrical repairs and adjustments to prepare vehicles for public sale; schedule required major engine and powertrain component repair with private vendors; maintain necessary vehicle fleet records; perform quality control inspection of vehicles returned from paint and body repair vendors; restore vehicles to original condition; inspect vehicle equipment such as passenger restraint systems, mirrors, windows, and accessories; and refurbish body moldings. |
| 10% | Maintain inventories of automotive parts, tires, batteries, oil, spark plugs, and filters; coordinate inventory movement, conduct used vehicle inventory, and update parts purchase order logs; and read and interpret computer-generated work orders reflecting bar-code technology. |
| 5% | Utilize and operate a tow truck to collect and transport non-operational vehicles to the state auction yard in Davis and Area offices in northern California; daily inspect and inventory tow truck and related equipment, tools, and rigging prior to use; maintain fluid levels according to manufacturer standards, perform minor truck service/maintenance activities as required; utilize hand tools to dismantle transported vehicles to salvage parts; and remove, bend, or cut off parts from damaged vehicles in preparation for towing. |
