Conducts and documents inspections of motor carrier terminal operations, complaint investigations, and other related inspections in accordance with departmental policy and guidelines set forth in HPM 84.1, Motor Carrier Safety Operations, to determine compliance with applicable laws and regulations primarily contained in the California Vehicle Code; Title 13, California Code of Regulation; Health and Safety Code; Public Utilities Code; and Title 49, Code of Federal Regulations. This includes, but is not limited to the following:

1. Completing in-depth inspections of commercial motor vehicles at terminal locations to determine compliance with state and federal requirements to maintain vehicles in safe and proper operating condition;
2. Auditing driver records to determine compliance with drivers' records of duty status, utilizes the Department of Motor Vehicles Pull Notice Program, drivers' medical certificates, training records, drivers' qualification files, and special certificates and/or endorsements for specific vehicle types;
3. Conducting in-depth inspections at terminal locations to determine compliance with applicable state and federal laws and regulations relative to required vehicle maintenance programs.
4. When applicable, inspecting for compliance with state and federal hazardous materials transportation and shipping requirements.

Conducts and documents carrier inspections at the principle place of business of motor carriers, complaint investigations, and other related inspections in accordance with departmental policy and guidelines set forth in HPM 84.1, Motor Carrier Safety Operations, to determine compliance with applicable laws and regulations primarily contained in the California Vehicle Code; Title 13, California Code of Regulation; Health and Safety Code; Public Utilities Code; and Title 49, Code of Federal Regulations. This includes, but is not limited to the following:

1. Conducting and documenting in-depth inspection of carrier's Controlled Substance and Alcohol Testing programs;
2. Investigation of complaints against motor carriers.

Prepares in-depth comprehensive written reports which may be used in the filing of criminal and/or civil complaints against motor carriers.
