30%	Instruct, supervise, and work with incarcerated persons painters and glaziers in the routine and preventive maintenance of painting institutional structures and equipment. Layout and instruct incarcerated persons in surface preparation, painting, weatherizing and related work.
25%	Oversee procedures for mixing and matching colors, tape and texture, spray painting, and brush and roller finishes. Assist other painters in large or complicated projects or painting work assignments.
20%	Maintain material inventory accountability and order materials for painting assignments. Ensure compliance with tool and material security control programs.
10%	Prepare incarcerated persons work reports and maintain incarcerated persons timekeeping records: record and maintain accurate time worked by incarcerated persons via the Strategic Offender Management System. Maintain the security of working areas, work materials, and tool control. Inspect work areas and search incarcerated persons for contraband, maintain incarcerated persons accountability, and enforce security programs. Provide safety training and enforce safety regulations.
10%	Daily monitoring of the Computerized Maintenance Management System (CMMS) including but not limited to review of incoming corrective and preventative maintenance work tasks, detailed logging of labor hours and materials utilized to complete repairs, ensuring thorough documentation of maintenance activities
5%	Perform administrative duties including, but not limited to adhere to Department policies, rules and procedures; submit administrative requests including leave, travel, and training in a timely and appropriate manner; accurately report time and submit timesheets by the due date. Other duties as required.
SPECIAL PERSONAL CHARACTERISTICS	
• Influence, change, and strengthen the community. Set an example each day through positive and pro-social role modeling, utilizing dynamic security concepts through observation and building rapport. • Willingness to play a significant role in the collaborative efforts toward rehabilitation and public safety enhancement. • Ability to facilitate conversations as a coach and mentor, engaging in a respectful and understanding manner. • Ability to build trust, improve communication, and assist with the transformation of correctional culture.
