DIVISION OVERVIEW				
The Division of Adult Parole Operations is responsible for protecting the community by enabling parole agents to play an active role in the local community's public safety plans and supporting the supervised population in their effort to successfully reintegrate into the community. The Division offers a wide range of programs and services and utilizes evidence-based tools to effect long-term behavior change for supervised individuals to earn an opportunity to discharge. The goal is to maintain gains during their parole period that will extend to post supervision. Following their release from incarceration, the Division supervises the most serious and violent persons in the state. The diverse population includes but is not limited to supervised persons with gang affiliations, persons sentenced to a life term, persons with mental illness, persons required to register pursuant to Penal Code 290, and Armstrong class members.				
GENERAL STATEMENT				

Under the direction of the Deputy Regional Administrator (Chief Deputy Administrator), the Parole Administrator I is responsible for planning, organizing and supervising parole field units. The Administrator has direct supervision over the supervisors of the units in that jurisdiction and indirect supervision over all staff assigned to those units. The Parole Administrator I performs the following duties:

35%	Direct supervision of Parole Agents III. Provide administrative direction and policy interpretation to supervisors and subordinates. Prepare probationary reports and annual performance appraisals. Second level review for other staff Consults with supervisors regarding personnel performance, grievances, adverse actions and normal unit operations. Provides orientation to new supervisors; monitor/review training of all supervisors. Participate in employment interviews, selection of staff. Monitor/review affirmative action goals.
20%	Monitor/review unit operations; monitor/review for delivery of services, controls, workload Direct audits of significant areas. In conformance with the Managerial Performance Appraisal Summary, formulates objectives to facilitate the accomplishment of Departmental goals. Objectives are used to measure work performance of Administrator and Unit Supervisors.
20%	Completes required reviews of reports by Agent/Unit Supervisor; complete first level review of supervised person appeals. Meet with supervised person and their families/friends to resolve problems and complaints. Develop and/or recommend contracts with local agencies for casework services. Liaison with law enforcement and social service agencies. Ensure positive public relations. Initiate public speaking engagements to provide information to the public regarding parole policies. Respond to media inquiries pertaining to sensitive and/or newsworthy parole incidents.
10%	Monitor/review case count distribution and balance unit boundaries when necessary. Monitor/review allocation of staff, resources, office space, and equipment.
5%	Review control documents (jail lists) as quality control before submission to headquarters Review billing verification for OHO and medical charges on supervised person(s)/incarcerated individuals and charges for security coverage by Sheriff's staff during hearings in local jails. Monitor/review regional budget allocation and advise staff on current budget funding status. Review/prepare Budget Change Proposals.
5%	Plan, organize, direct, and evaluate the work and performance of staff. This includes but is not limited to the following: Comply with state and federal laws, rules, regulations, bargaining unit contracts, and policies in all personnel practices, including, but not limited to hiring, employee development, and management. Recruit, hire, train, develop, and provide leadership to a diverse staff. Monitor, evaluate, and create written performance appraisals of staff. Counsel staff and initiate disciplinary actions, as necessary. Identify appropriate long-range plans and goals to address succession planning and knowledge transfer.
5%	Perform administrative duties including, but not limited to: adhere to Department policies, rules and procedures; submit administrative requests including leave, travel, and training in a timely and appropriate manner; accurately report time and submit timesheets by the due date.

SPECIAL PERSONAL CHARACTERISTICS

- Influence, change, and strengthen the community. Set an example each day through positive and pro-social role modeling, utilizing dynamic security concepts through observation and building rapport.
- Willingness to play a significant role in the collaborative efforts toward rehabilitation and public safety enhancement.
- Ability to facilitate conversations as a coach and mentor, engaging in a respectful and understanding manner.

- Ability to build trust, improve communication, and assist with the transformation of correctional culture.

SPECIAL REQUIREMENTS

- CDCR does not recognize hostages for bargaining purposes. CDCR has a "NO HOSTAGE" policy, and all prison individuals, visitors, nonemployees and employees shall be made aware of this.
- Maintenance of peace officer standards and training in accordance with Penal Code 832 and Department Operations Manual sections 32010.19.1, 33020.13, and 86010.13.
