POSITION DESCRIPTION

Positions at this level may exist in field offices, area offices, and central office. This is the journey level in the series. Incumbents perform the more difficult and complex technical work and analysis with a minimum of supervision; may be assigned total responsibility for a specific project having regional or statewide impact; formulate policies and procedures and make recommendations to management on the full range of Disability Insurance issues, problems, and concerns, and prepare reports and correspondence in these same areas. As a technical expert in a particular program area, may act in a consulting capacity to the field and other departmental staff by providing problem-solving advice and program information; may have regional or statewide responsibility for coordinating activities in a particular program or program area ensuring consistent application of policies, procedures, and standards.

As a journey level specialist, may provide assistance to lower level specialists by responding to technical questions; providing feedback on assignments, and instructing them on data collection, information gathering and dissemination, report and correspondence preparation, and other aspects of program support work. These lead person duties are always performed in conjunction with a working assignment and should not constitute over 50 percent of an employee's time.

Positions exist statewide.

WHO SHOULD APPLY

Applicants who meet the minimum qualifications as stated on this bulletin may apply for this examination.

This is a **DEPARTMENTAL EXAMINATION** for the **Employment Development Department (EDD)**. Competition is limited to:

- 1. Employees who have a permanent civil service appointment with the EDD by the final filing date; or
- 2. Current or former employees of the Legislature with two or more years as defined in the Government Code 18990; or
- 3. Current or former non-elected exempt employees of the Executive Branch with two or more consecutive years as defined by Government code 18992; or

WHO SHOULD APPLY (CONTINUED)

4. Persons retired from the United States military, honorably discharged from active military duty with a service-connected disability, or honorably discharged from active duty as defined in Government Code 18991. Veterans must provide a copy of their DD214 for entrance requirements. Please attach your DD214 to your application. Veterans' preference will not be granted in promotional examinations.

For applicants under items 2, 3, or 4 above, if promotional examinations are given by more than one department for the same classification, the applicant must select one department in which to compete. Refer to the General Information, Promotional Examinations Only section of this bulletin for other eligibility requirements. Under certain circumstances, former EDD employees may be allowed to compete under the provision of Rule 235.

MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements for this examination by the final filing date, June 17, 2021.

Qualifying experience may be combined on a proportionate basis if the requirements stated below include more than one pattern and are distinguished as "Either I" "Or II". For example, candidates' possessing qualifying experience amounting to 50% of the required time of Pattern I, and additional experience amounting to 50% of the required time of Pattern II, may be admitted to an examination as meeting 100% of the overall experience requirements.

EITHER I

One year of experience in the California state service performing the duties of a Disability Insurance Specialist I, Range B, or Disability Insurance Program Supervisor. (Candidates who are within six months of completing the required experience will be admitted to the examination, but they must complete the required experience before they can be considered eligible for appointment.)

OR II

Four years performing technical or management work in the field of claims eligibility determinations or adjustments under public or private insurance or health and welfare benefit plans. Three years of the required experience must have been in an analytical staff capacity. (Experience in California state service applied toward this pattern must include at least one year of experience performing the duties of a class with a level of responsibility not less than that of Disability Insurance Program Supervisor.)

All Examination Applications must be **POSTMARKED or received** no later than the final filing date in order to be considered for the examination. Mobile barcodes or equivalent mobile print technology are **not acceptable** proof of the date the application and any other required documents or materials were mailed/filed.

Applications not sent through the U.S. Postal Service, parcel delivery or courier service (i.e., hand carried to the Human Resource Services Division) must be **RECEIVED BY 4:30 P.M. ON THE FINAL FILING DATE.** Use of EDD metered mail, interoffice mail (e.g., red or gold bag), and faxed applications are prohibited.

SIGNATURE REQUIRED: Applications submitted for this examinations via USPS, hand delivery or email, **MUST** have an original signature. E-signatures will be accepted.

NOTE: All applicants **MUST** provide a current, valid email address on their application. The Qualifications Assessment (QA) examination link will be sent to the email address provided. Failure to provide a current and valid email address may result in non-receipt of examination information, in a timely manner, which could result in disqualification from the examination. All examination notifications (except the QA link) will be sent by mail.

Applications must also contain the following information: "to" and "from" dates (month/day/year) of employment, time base, civil service class title(s), and range, if applicable. In addition, college course information MUST include: title, semester or quarter credits, name of institution, completion dates, and degree (if applicable). Applications received without this information may be rejected.

SPECIAL TESTING ARRANGEMENTS

If you need an accessible test location, an interpreter, or other special testing arrangements because of a disabling condition or your religious beliefs, please complete question 10 on page 1 of the Examination Application <u>STD 678</u> and complete the Request for Reasonable Accommodation form <u>STD 679</u>. You will be contacted and necessary arrangements will be made.

EXAMINATION INFORMATION

This examination will consist of a **Qualifications Assessment** weighted 100%. In order to obtain a position on the eligible list, a minimum rating of **70% must be attained**.

QUALIFICATIONS ASSESSMENT – WEIGHTED 100%

It is anticipated that candidates who meet the minimum qualifications for this examination will be sent an email **the week of July 5, 2021** to the email address provided on their application. The email will contain the instructions and the link to complete the online Qualifications Assessment (QA) examination. **PLEASE NOTE:** Candidates will have 7 calendar days to complete the QA from the date emailed. The QA <u>will not</u> be accessible after 5:00pm on the 7th day.

It is the candidate's responsibility to contact the Human Resource Services Division at <u>EDDExaminations@edd.ca.gov</u> if they have not received an email with the QA link by July 8, 2021. Please monitor your email account's SPAM, Junk, Bulk, etc. folder(s) as the examination email may be filtered depending on your specific account settings.

Names of successful competitors will be merged onto the existing **DEPARTMENTAL PROMOTIONAL** list in order of final scores regardless of test date. List eligibility will expire **24** months after it is established. **COMPETITORS MAY COMPETE ONLY ONCE IN ANY CONSECUTIVE 6-MONTH PERIOD.**

VETERANS' PREFERENCE

Veterans' Preference credits will **not** be granted in the examination as it does not meet the requirements to qualify for Veterans' Preference credit.

CAREER CREDITS

Career Credits will not be added to the final score of this examination.

SCOPE OF THE EXAMINATION

KNOWLEDGE OF:

- 1. Interviewing techniques.
- 2. Principles of insurance payments programs.
- 3. Public administration.
- 4. Provisions of the California Unemployment Insurance Code.
- 5. The rules, regulations, policies, and procedures of the Employment Development Department.
- 6. Precedent decisions of the California Unemployment Insurance Appeals Board relating to the disability insurance programs.
- 7. Medical terminology and common medical references used in interpreting medical findings.
- 8. Employment practices and conditions and physical demands of occupations in industrial, domestic, professional, commercial, and agricultural employment in California.
- 9. Workers' compensation and employer liability laws affecting California workers and provisions of State and Federal laws affecting disability insurance programs.
- 10. Practices followed by insurance companies in California in underwriting disability insurance coverage and by other states in their disability insurance program.
- 11. Principles and practices of public administration and personnel management.
- 12. Office management principles and practices.

- 1. Gather and analyze data.
- 2. Reason logically and accurately.
- 3. Comprehend written material, and interpret and apply rules and instructions.
- 4. Communicate effectively.
- 5. Establish and maintain cooperative relations with others.
- 6. Analyze situations accurately and take effective action.
- 7. Develop, instruct, and evaluate in-service training programs.
- 8. Analyze operations.
- 9. Evaluate suggestions.
- 10. Develop standards, policies, and procedures for disability insurance programs.

If you meet the requirements stated on this bulletin you may take this examination, which is competitive. Possession of the entrance requirement(s) does not ensure a place on the eligible list. Your performance in the examination described on this bulletin will be compared with the performance of the other candidates who take this examination, and all candidates who pass will be ranked according to their scores.

GENERAL QUALIFICATIONS: Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, an ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class.

ELIGIBLE LISTS: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open eligible list. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on this bulletin. In the case of continuous testing examinations, names are merged into the appropriate eligible lists in order of final examination scores regardless of the date of the examination and the resulting eligible lists will be used only to fill vacancies in the area shown on the bulletin.

PROMOTIONAL EXAMINATIONS ONLY: Veterans Preference are not granted in promotional examinations. Competition is limited to those applicants who meet one of the criteria listed on page 1 of this bulletin. Under certain circumstances other employees may be allowed to compete under provisions of Rules 234, 235, and 235.2. State Personnel Board Rules 233, 234, 235, 235.2, and 237 contain provisions regarding civil service status and eligibility for promotional examinations.
