INTRODUCTION TO THE LEAP PROGRAM

The Limited Examination and Appointment Program (LEAP) is an alternative examination and appointment process designed to facilitate the recruitment and hiring of persons with disabilities into the State of California civil service. The LEAP examination process is a two-part process that consists of: (1) a Minimum Qualifications Assessment (Readiness Evaluation) <u>and</u> (2) a Job Examination Period that is administered and evaluated in the work setting.

To qualify to take this LEAP Minimum Qualifications Assessment (Readiness Evaluation), you <u>must</u> first have LEAP certification issued by the Department of Rehabilitation (DOR). For information regarding obtaining LEAP certification from the DOR, visit the <u>Department of Rehabilitation website</u> and use the search term LEAP Certification. There you will find a link to Find an Office. Alternatively, to find a DOR office near your home, call (916) 558-5300, TTY (916) 558-5302.

The legal authority for the Limited Examination and Appointment Program is Government Code Sections 19240-19244.

APPLICATION INSTRUCTIONS

Who Should Apply:

Persons who meet all of the following criteria:

1. Individuals with a disability, a record of a disability, or who are regarded as having a disability that limits one or more major life activities;

- 2. Individuals who have Limited Examination and Appointment Program (LEAP) certification from the California Department of Rehabilitation
- 3. Individuals who satisfy the minimum qualifications as stated in the minimum qualifications section below

Once you have passed this Minimum Qualifications Assessment (Readiness Evaluation), you may not retake it for **24 months**.

MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be able to pass this LEAP Minimum Qualifications Assessment (Readiness Evaluation). Part-time or full-time jobs, regardless of whether paid or volunteer or inside or outside California state service, may count toward experience.

Community College Administrator 1 (LEAP)

Education: Possession of an earned bachelor's degree granted by an accredited institution of higher education or equivalent degree or equivalent completion of 120 semester units or 180 quarter units. Additional qualifying experience may be substituted for the required education on a year-for-year basis. **And**

Experience: Either I

One year of experience in the California state service performing education and/or administration duties, in an education program or in fiscal or facilities planning program, of a class with a level of responsibility equivalent to a Community College Specialist; **or**

Three years of increasingly responsible professional experience providing education program administration, consultation facilities planning, fiscal planning or monitoring, and/or other complex technical education program assistance. Education Programs may include:

academic affairs, educational facilities planning, educational fiscal planning or monitoring, general vocational education programs or student services or similar coordinative function.

POSITION DESCRIPTION

Community College Administrator 1 (LEAP)

This is the first supervisory level and functions as either a program chief or senior staff person on a major project in a nonsupervisory capacity. As a supervisor, incumbents plan and direct the development, administration and evaluation of an ongoing statewide Community College specialty area such as academic programs, equal employment opportunity programs, student services, facilities and financial planning and administration, information services, or vocational education program development or program operation. Incumbents typically supervise three or more subordinate professional staff engaged in research and consultative activities and report directly to either a Community College Administrator II, Assistant Vice Chancellor or Vice Chancellor. Nonsupervisory positions in this class perform high level administrative, coordinative, and consultative duties on the most complex assignments which are characterized in their impact by being systemwide, intersegmental, interunit, interdisciplinary, controversial, and legislatively sensitive in nature and report to either a Community College Administrator II, Assistant Vice Chancellor or Vice Chancellor level.

MINIMUM QUALIFICATIONS ASSESSMENT (READINESS EVALUATION) SCOPE

This assessment consists of the following test component:

Minimum Qualifications Assessment (Readiness Evaluation) - Pass or Fail

To obtain a position on the **Community College Administrator 1 (LEAP)** referral list, a pass result must be received. Applicants will receive their result upon completion of this Minimum Qualification Assessment.

REFERRAL LIST INFORMATION

A departmental, open referral list for the **Community College Administrator 1 (LEAP)** classification will be established for the California Community Colleges Chancellor's Office.

The names of persons who successfully pass this Minimum Qualifications Assessment (Readiness Evaluation) will be merged onto a LEAP Referral List for the **Community College Administrator 1 (LEAP)** classification. Candidates who pass the Minimum Qualifications Assessment (Readiness Evaluation) will remain on the list for 24 months. All State departments may use the **Community College Administrator 1 (LEAP)** Referral List to select candidates for vacant positions.

LEAP Referral List eligibility expires 24 months after it is established. Competitors must then retake the **Community College Administrator 1 (LEAP)** Minimum Qualifications Assessment to reestablish list eligibility

LEAP EXAMINATION PROCESS INFORMATION

<u>PART 1: MINIMUM QUALIFICATIONS ASSESSMENT (READINESS EVALUATION) – Weighted 100%</u>

This LEAP Minimum Qualifications Assessment (Readiness Evaluation) consists solely of minimum qualification questions that assess the training, experience and education that you have previously obtained. Your responses to the questions will determine if the

training, experience, and education you have, meet the minimum qualifications for the Community College Administrator 1 classification. If your Minimum Qualifications Assessment (Readiness Assessment) result is "pass", your name will be placed on the Community College Administrator 1 Referral List and you will have referral list eligibility to apply for Community College Administrator 1 vacancies.

Applicants who obtain Community College Administrator 1 LEAP Referral List eligibility must compete for state of California job vacancies in order to begin PART 2 of this process, which is called the JOB EXAMINATION PERIOD (JEP).

PART 2: JOB EXAMINATION PERIOD (JEP)

The JEP begins after you are hired and obtain an examination appointment. When you perform the duties of your state job, you will be evaluated on your job performance every four weeks or more often. Your evaluation will be based on the classification specification and the duty statement of the position.

The JEP will be the same length as the length of the probationary period for the same non-LEAP classification.

After successful completion of both the Minimum Qualifications Assessment and the JEP, the result will be a transition from an examination appointment to a standard appointment as a Community College Administrator 1. If appointed through the LEAP examination process, you will not be required to serve a probationary period.

Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.
