This is a Departmental Open Statewide examination for the State Compensation Insurance Fund which received approval from the Department of Industrial Relations (DIR) and the California Department of Human Resources to utilize this DIR specific classification.

ELIGIBLE LIST INFORMATION

An OPEN, MERGED eligible list will be established for State Compensation Insurance Fund. The names of successful competitors will be merged onto the eligible list in order of final scores regardless of the test date. Candidate's eligibility expires twelve (12) months after it is established. Competitors must then retake the exam to reestablish eligibility.

MINIMUM QUALIFICATIONS

Either I

In the California state service either:

1. One year of experience performing the duties of a Senior Safety Engineer; Senior Industrial Hygienist; District Manager, Division of Occupational Safety and Health; Area Manager, CAL/OSHA Consultation Service; **or**
2. Three years of experience performing the duties of an Associate Safety Engineer or Associate Industrial Hygienist.

Or II

Experience: Five years of responsible experience as a safety engineer or industrial hygienist with overall responsibility for organizing and administering a comprehensive safety or industrial hygiene program, at least one year of which must have been in an administrative or supervisory capacity with responsibility for supervision of the work safety engineers or industrial hygienists.

And

Education: Equivalent to graduation from college with major work in engineering, industrial hygiene, environmental health, chemistry, biology, physics, medicine, public health, or in a field directly related to occupational safety and health. (Additional qualifying experience may be substituted for the required education on a year- for-year basis.)

POSITION DESCRIPTION

Under the direction of the Senior Vice President Safety and Health the incumbent has management authority over a multi-disciplinary team of Area Managers, Senior Safety Engineers, Associate {Loss Prevention} Safety Engineers, Industrial Hygienists, Ergonomists, and Loss Prevention Consultants providing a full range of safety and health consultation and training services designed to encourage and assist State Fund policyholders to prevent or reduce employee injuries and illnesses and the workers' compensation claims that result. Services also include assisting employers statewide with information and training on select workplace safety and health topics.

EXAMINATION INFORMATION

TRAINING & EXPERIENCE (T&E) EXAMINATION-Weighted 100.00%

The sole component of the Regional Manager, Division of Occupational Safety and Health examination will consist of a T&E Examination. To obtain a position on the eligible list, a minimum score of 70% must be received.

Applicants are required to respond to the T&E questions provided on this announcement. For each listed task statement within the T&E examination, applicants will need to provide the following:

- 1) Identify the one professional reference who can best verify the response you provide for each task statement (Within the T&E you will have an opportunity to pre-list up to five professional references and from this listing you will identify the one professional reference).
- 2) Identifying level of proficiency rating and experience rating.
- 3) Provide a brief narrative example for each task.

Any task statement missing a professional reference, level of proficiency rating, experience rating, or a brief narrative example will **not** be scored.

TRAINING & EXPERIENCE (T&E) EXAMINATION – WEIGHTED 100.00%

Rankings will be determined based on the depth and breadth of professional education and experience beyond what is minimally required. Emphasis will be placed on measuring:

1. Engineering and industrial hygiene principles and methods
2. Principles and practices of safety engineering and industrial hygiene
3. State safety and health laws, the Safety and Health Rules and Orders of the Division of Occupational Safety and Health and applicable provisions of the Labor Code and Health and Safety Code
4. Accident prevention techniques
5. Industrial health hazards
6. Basic legislation concerning the Division of Occupational Safety and Health
7. Methods of organizations, planning, management and supervision
8. Purposes, organization and activities of the Division of Occupational Safety and Health
9. The Division's Equal Opportunity Program objectives
10. A manager's role in the Equal Opportunity Program and the processes available to meet equal opportunity objectives

Ability to:

1. Effectively plan, organize, and coordinate the work of a multidisciplinary engineering and industrial hygiene field team
2. Interpret and apply State safety and health laws, the Safety and Health Rules and Orders of the Division of Occupational Safety and Health and applicable provisions of the Labor Code and the Health and Safety Code
3. Analyze injury and illness data and develop appropriate accident and illness prevention techniques
4. Use good judgment and take appropriate action in emergencies

VETERANS' PREFERENCE

Veterans' Preference will be granted in this examination.

Effective January 1, 2014, in accordance with Government Codes 18973.1 and 18973.5, Veterans' Preference will be awarded as follows: 1) Any veteran, widow or widower of a veteran, or spouse of a 100 percent disabled veteran, who achieves a passing score in an entrance examination, shall be ranked in the top rank of the resulting eligibility list. Any veteran who has been dishonorably discharged or released is not eligible for Veterans' Preference. 2) An entrance examination is defined, under the law, as any open competitive examination. And 3) Veterans' Preference is not granted once a person achieves permanent civil service status. Veteran status is verified by the California Department of Human Resources (CalHR). GENERAL INFORMATION

Applications are available at www.jobs.ca.gov, California Department of Human Resources offices, local offices of the Employment Development Department and the State Compensation Insurance Fund.

If you meet the requirements stated on this bulletin, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list. Your performance in the examination will be compared with the performance of the others who take this test, and all candidates who pass will be ranked according to their scores.

State Compensation Insurance Fund reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all competitors will be notified.

Where to Apply: A Standard State Fund Application (STD 678) is required for this examination and can be submitted via the State Fund Jobs Online feature at <https://www.statefundca.com/careers/CurrentExams>. Competitors must register for a State Fund Jobs Online login and password in order to complete and submit the required Standard State Application.

For an examination without a written feature, it is the candidate's responsibility to contact State Compensation Insurance Fund, Human Resources at 1.800.499.8668 three weeks after the final filing date if he/she has not received a progress notice.

General Qualifications: Candidates must possess essential personal qualifications including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Hiring Interview Scope: In a hiring interview, in addition to the scope described in this bulletin, the panel will consider education, experience, personal development, personal traits, and fitness. In appraising experience, more weight may be given to the breadth and recency of pertinent experience and evidence of the candidate's ability to accept and fulfill increasing responsibilities than to the length of his/her experience. Evaluation of a candidate's personal development will include consideration of his/her recognition of his/her own training needs; his/her plans for self-development; and the progress he/she has made in his/her efforts toward self-development. For more information, you may refer to the classification specification.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.
