Once you have taken this examination, you may not retake it for **nine (9) months**.

MINIMUM QUALIFICATIONS

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Senior Emergency Services Coordinator, Office of Emergency Services Either 1

Experience: One year of experience in the California state service performing the duties of a class with a level of responsibilities <u>equivalent to an Emergency Services</u> <u>Coordinator</u>, <u>Officer of Emergency Services</u>, <u>Range B</u>.

Or 2

Experience: Three years of broad and progressively responsible experience performing analytical staff duties in an interdisciplinary setting on projects with substantial public contact and resulting in the preparation, presentation, and implementation on long-range comprehensive plans, procedures, and reports related to programs for emergency management or emergency response. (State experience applied toward this pattern must include two years of experience performing duties equivalent in level to an Emergency Services Coordinator, Office of Emergency Services, Range B.) **And**

Education: Equivalent to graduation from college. (Additional qualifying experience may be substituted for the required education on a year-for-year basis.)

Driver's License Requirement

Possession of a valid driver's license of the appropriate class issued by the Department of Motor Vehicles is required. Applicants who do not possess the license will be admitted to the examination but must secure the license prior to employment.

POSITION DESCRIPTION

Senior Emergency Services Coordinator, Office of Emergency Services

This is the advanced journey level of the series. Under general direction, incumbents perform the most complex, difficult, and sensitive emergency management, emergency response, recovery, and planning work above the journey level; are independently responsible for a significant, specialized emergency management project; may serve as lead person, team leader, and/or project coordinator on the most difficult and complex emergency management projects; formulate program and policy direction and alternatives which are highly complex, and select and develop methodologies for their implementation; serve as technical program expert; consult and negotiate with local jurisdictions, State and Federal agencies, organizations, and community groups regarding major program development issues or operations; mentor new staff and review technical work products of staff; analyze legislation having a statewide program impact and recommend legislative proposals, implementation, and strategic planning.

Special Personal Characteristics

Demonstrates ability to be flexible and a willingness to work effectively under adverse conditions; tact and professional demeanor; travel for extensive periods at any time emergencies arise, including weekends and holidays; and work odd hours and long shifts.

EXAMINATION SCOPE

This examination consists of the following components:

Training and Experience Evaluation – Weighted 100% of the final score.

The examination consists solely of a **Training and Experience Evaluation**. To obtain a position on the eligible list, a minimum score of 70% must be received. Applicants will receive their score upon completion of the Training and Experience Evaluation process.

In addition to evaluating applicants' relative knowledge, skills, and ability, as demonstrated by quality and breadth of education and/or experience, emphasis in each exam component will be measuring competitively, relative job demands, each applicant's:

Knowledge of:

- 1. Mission, goals, objectives, and organization of emergency management and emergency response.
- 2. Operations and structure of government; processes, principles, and regulations applied in the administration of emergency management programs.
- 3. State and Federal laws, regulations, and requirements relating to local, State, and Federal emergency management planning and emergency response.
- 4. Apply professional knowledge and ability to all situations.
- 5. Principles, concepts, and terminology in emergency management, emergency response and planning processes, hazard mitigation, and community preparedness.
- 6. Laws and regulations pertaining to State and Federal financial assistance and mutual aid.
- 7. Current trends of emergency management, emergency response, recovery, and planning.
- 8. Methods of program report preparation and program reporting techniques.
- 9. Basic techniques of data analysis.
- 10. Basic computer skills.
- 11. Objectives and organization of emergency management and emergency response.
- 12. Principles and techniques of organization, administration, and management.
- 13. Purposes, activities, and legislation of the Office of Emergency Services.

Ability to:

- 1. Plan for emergencies and respond, under all conditions, appropriately to emergencies and disasters by applying emergency management principles to the specific immediate situation.
- 2. Apply professional knowledge and ability to all situations of coordination, planning, and mitigation of hazards, and communicate risks to specific emergency management situations.
- 3. Interpret emergency management-related laws and their application to program or incident situations.
- 4. Develop and implement new and revised methods and procedures.
- 5. Establish and maintain cooperative working relationships with staff, local, State, and Federal officials, and representatives of other organizations.
- 6. Prepare complete and comprehensive reports and recommendations.
- 7. Communicate and write effectively.
- 8. Reason logically.
- 9. Analyze problems and situations accurately and take effective action.

- 10. Work independently in identifying needs and emergency management systems deficits and developing recommendations for improvement of emergency management planning and emergency response operations.
- 11. Act as a lead person or as a team leader.
- 12. Train other staff in principles and methods.
- 13. Provide effective leadership.

ELIGIBLE LIST INFORMATION

A departmental, open eligible list for the **Senior Emergency Services Coordinator**, **Office of Emergency Services** classification will be established for:

California Governor's Office of Emergency Services.

The names of successful competitors will be merged onto the eligible list in order of final score regardless of exam date. Eligibility expires **twelve (12) months** after it is established. Applicants must then retake the examination to reestablish eligibility.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veterans status is verified by the California Department of Human Resources (CalHR). Information on this program and the Veterans' Preference Application (Std. form 1093) is available online. Additional information on veteran benefits is available at the Department of Veterans Affairs.

Career Credits **will not** be applied to the final score of competitors who are successful in this examination.

GENERAL INFORMATION

Examination and/or Employment Application (STD 678) forms are available at the California Department of Human Resources (CalHR), local offices of the Employment Development Department, and through your <u>CalCareer Account</u>.

If you meet the requirements stated on this examination bulletin, you may take this examination, which is competitive. Possession of the entrance requirements does not assure a place on the eligible list. Your performance in the examination described in this

bulletin will be rated against a predetermined job-related rating, and all applicants who pass will be ranked according to their score.

The California Governor's Office of Emergency Services reserves the right to revise the examination plan to better meet the needs of the service, if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service laws and rules and all applicants will be notified.

General Qualifications: Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on the bulletin.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
