Applicants who meet the minimum qualifications (entrance requirements) in this announcement and who have not taken the examination in the last **12** months may apply for this examination.

EXAMINATION INFORMATION

This examination consists of Training and Experience Self-Assessment examination weighted 100%. In order to obtain a position on the eligible list, a minimum rating of 70% must be attained.

Testing is considered continuous as exam dates can be set at any time. The testing office will accept applications continuously and will notify and test applicants as needs warrant.

PREPARING FOR THE EXAMINATION

ELIGIBLE LIST INFORMATION

Names of successful candidates will be merged onto the existing California Prison Industry Authority eligible list in order of final scores regardless of test date. Eligibility expires **12** months after it is established. Competitors must then retest to reestablish eligibility. Competitors may retest after **12** months. The resulting eligibility list will be used to fill vacancies at California Prison Industry Authority. A departmental OPEN eligible list will be established for the California Prison Industry Authority. Eligibility expires **12** months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

POSITION DESCRIPTION

Technical experience in the fabrication of the full range of dental prosthetic products, including lead capacity over entry level staff or inmate staff within a correctional facility.

An Industrial Supervisor, Prison Industries (Dental Laboratory) plans and schedules production including labor, materials, and equipment; coordinates and/or supervises installation, operation, maintenance, and repair of equipment and/or machinery; makes recommendations to increase production efficiency and product quality; trains, counsels, and supervises offenders or residents in production work, quality control, safety, and personnel development; evaluates their performance and recommends appropriate action; assists in budget preparation and makes recommendations for needed materials, labor, and equipment; supervises preparation of records and reports on production, processing, and inventories; maintains order and supervises the conduct of persons committed to the California Department of Corrections and Rehabilitation; prevents escapes and injury by these persons to themselves or others or to property; maintains security of working areas and work materials; inspects and searches premises for contraband, such as weapons or illegal drugs; and does other related work.

REQUIREMENTS FOR ADMITTANCE TO THE EXAMINATION

It is your responsibility to make sure you meet the education and/or experience requirements as stated on this announcement as of the date this test is taken.

MINIMUM QUALIFICATIONS

Two years of experience in the fabrication of the full range of dental prosthetic products of which one year shall have been in a lead capacity over entry level staff or inmates in a correctional facility, responsible for the fabrication of such products. (Education, such as trade school, vocational education, or a major in the trade at the community college, college, or university level, may be substituted for the required experience on the basis that two years of education is equal to one year of the required work experience. Such education must include two years of course work in the specified industrial operation.)

<u>Promotional Candidate</u>: Promotional candidates, including employees on training-and-development assignments, who are within six months of meeting the "Minimum Qualifications" for the specified promotional class, will be admitted to the examination, but first must complete the required experience before they can be eligible for appointment.

All applicants must meet the education and/or experience requirements as stated on this exam bulletin to be accepted into the examination. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

Applications MUST contain the following information: "to" and "from" dates (month/day/year), time base, civil service class title(s), and range, if applicable. College course information MUST include title, semester, or quarter credits, name of institution, completion dates, and degree (if applicable).

Applications received without this information may be rejected.

PROOF OF EDUCATION

Applicants using education to meet the minimum requirements must provide a copy of their diploma, official/unofficial transcript, statement and/or evaluation from an accredited U.S. college or university with their examination application. If any applicant is not able to provide proof of education from a recognized institution at the time of appointment, their name may be removed from the eligible list(s).

FOREIGN DEGREES

Applicants with foreign transcripts must provide an official/unofficial foreign transcript evaluation that indicates the number of units to which his/her foreign course work is equivalent. Tact, patience, and ability to work with persons confined in a correctional institution.

SPECIAL PHYSICAL CHARACTERISTICS

Persons appointed to positions in this class must be reasonably expected to have and maintain sufficient strength, agility, and endurance to perform during stressful (physical, mental, and emotional) situations encountered on the job without compromising their health and well-being or that of their fellow employees or that of offenders. Assignments during tour of duty may include sole responsibility for the supervision of offenders and/or the protection of personal and real property.

ADDITIONAL DESIRABLE QUALIFICATIONS

Supervisory experience; education equivalent to completion of the twelfth (12) grade; and assertiveness. Dental laboratory experience within a correctional facility; certification as a Dental Laboratory Technician by the National Board for Certification; completion of a dental technology program accredited by the Commission on Dental Accreditation.

SCOPE

In addition to evaluating the competitors' relative abilities as demonstrated by quality and breadth of experience, emphasis on the Qualification Assessment Questionnaire will be on measuring competitively relative to job demands, each competitor's:

Knowledge of (with particular reference to Dental Laboratory):

- 1. Methods, materials, machinery, processes, tools and equipment used in industrial operations to fabricate full and partial dentures.
- 2. Production scheduling and control to ensure work is completed in a timely manner.
- 3. Quality standards and control to maintain the integrity of the end product.
- 4. Safety practices to maintain an accident free working environment.
- 5. Materials handling techniques for removable dentures to carry out work assignments.
- 6. Principles of personnel management and supervision efficiently to effectively complete assigned duties.
- 7. Basic computer skills, including document creation, spreadsheets and California Prison Industry Authority computer operating systems to ensure efficient record keeping.

Ability to (with particular reference to Dental Laboratory):

- 1. Set-up, maintain, adjust, operate and perform minor repairs of equipment to keep the laboratory running efficiently.
- 2. Make labor and material estimates to complete projects and assignments in a cost effective manner.
- 3. Instruct and supervise staff, offenders, or residents in production techniques and safety practices to effectively achieve California Prison Industry Authority goals.
- 4. Maintain firm and impartial and consistent discipline to comply with CDCR's rules and regulations.
- 5. Understand rules, regulations, laws, and procedures to accomplish program goals and objectives.
- 6. Analyze situations accurately and take effective action to determine and implement appropriate courses of action.
- 7. Keep records and prepare reports compile and manage information to accurately document, compile and manage information.
- 8. Communicate effectively at a level required for a successful job performance to ensure information and concepts are clearly and concisely conveyed.

VETERAN'S PREFERANCE

Veterans' Preference will be granted for this examination. In accordance with Government Code 18793.1 and 18973.5, whenever any veteran, or widow or widower of a veteran, achieves a passing score on an open examination, they shall be ranked in the top rank of the resulting eligibility list.

GENERAL INFORMATION

California Prison Industry Authority reserves the right to revise the examination plan to better meet the needs of the service if the circumstances under which this examination was planned change. Such revision will be in accordance with civil service law and rules and all competitors will be notified accordingly.

For an examination without a written feature, it is the candidate's responsibility to contact the California Prison Industry Authority at (916) 358-2696 three weeks after the final filing date if he/she has not received a progress notice.

If you meet the requirements, you may take this examination, which is competitive. Possession of the entrance requirement does not assure a place on the eligible list.

Applications are available at California Department of Human Resources (CalHR), local offices of the Employment Development Department, the California Prison Industry Authority-Human Resources, and online at www.calpia.ca.gov.

Eligible Lists: Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) servicewide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first. Eligible lists will expire in one to four years unless otherwise stated on this bulletin.

General Qualifications: Applicants must possess essential personal qualifications, including integrity, initiative, dependability, good judgment, and ability to work cooperatively with others; and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required. In open examinations, investigation may be made of employment records and personal history and fingerprinting may be required.

Background Investigation: If you are successful in this examination, you may be required to complete a background investigation form disclosing information on arrests and driving violations. Candidates will be fingerprinted to search fingerprint files to disclose any criminal record. The hiring agency will use this information to determine your suitability to become a California Prison Industry Authority employee. Information collected for a background investigation is distinct from that required on the Examination Application (STD 678) which is completed prior to the examination. You will be required to divulge arrest and/or conviction information on the background investigation document that is not required when completing the Examination Application.

High School Equivalence: Equivalence to completion of the 12th grade may be demonstrated in any one of the following ways: 1) passing the General Education Development (GED) Test; 2) completion of 12 semester units of college-level work; 3) certification form the State Department of Education, a local school board, or high school authorities that the competitor is considered to have education equivalent to graduation from high school; or 4) for clerical and accounting classes, substitution of business college work in place of high school on a year-for-year basis.
